Things to know:

- ▶ Instructor of Record
 - ▶ VERY important to get this right!
 - ▶ This data controls
 - ▶ Canvas,
 - ▶ Course Evaluations,
 - ▶ Grading and Grade Changes
 - ▶ It is a FERPA violation to have extraneous people listed as instructor of record (in most cases).

Biggest issues

- ▶ Classrooms being locked: get a classroom key
- ▶ Faculty not sharing the passing time between classes
- ▶ Shenanigans
 - ▶ Making CRNs to help students avoid time conflict policy

Grades:

Grades are the faculty's assessment, using a standard UO rubric, of a student's learning/participation in a course during a specific academic period which is then recorded on the official transcript.

Grade Culture: Addressing Grade Inflation

- ▶ UO Senate motion of April 13, 2011:
- ▶ By the end of Fall 2011, each department and undergraduate program shall have formulated a rationale for its grading practices and posted this on its official website.

Common Questions/Confusion

Plus/Minus

- ▶ 4.3
- ▶ 4.0
- ▶ 3.7
- ▶ 3.3
- ▶ 3.0
- ▶ Etc...

- ▶ Yes, students can have a term GPA higher than a 4.0
- ▶ Yes, students can have a cumulative GPA higher than a 4.0

Pass, No Pass

Pass*, No Pass*

- ▶ UG students: need a C- or better to earn a Pass or Pass*
- ▶ Grad students: need a B- or better to earn a Pass or Pass*

Pass, No Pass

- ▶ P/NP: course offered for optional grading; student registers for the default option of graded and then changes the class to P/NP.
- ▶ UG students need 168 graded or P* credits, so that means there's a limit of 12 credits of P/NP
- ▶ Deadline to change: end of week seven

Pass*, No Pass*

- ▶ P*/NP*: course offered *only* as Pass/No Pass; student registers for the class and that grading option is already set.
- ▶ P* grading option is why you see marks like I*, W*, X* and Y*
- ▶ UG students need 45 ABCD graded credits to graduate (and have to have earned a 2.0 minimum)

Incompletes

- ▶ Student has to be doing passing work
 - ▶ C- for Undergrads
 - ▶ B- for Grads
- ▶ Student has some minor but essential course requirement outstanding for reasons acceptable to the instructor (like a final paper or exam).
- ▶ Faculty and student should develop a contract (what work is to be done and by when).

Incompletes

- ▶ NO PLACEHOLDER grades!!!!
- ▶ NO telling the student to sit through the class in a future term to make up the work.
- ▶ NO telling the student to register for the class for a future term to make up the work.

Incompletes

- ▶ For UG's, Incompletes change to F (whichever is earlier):
 - ▶ After one year
 - ▶ At the term of graduation application (whether the student graduates or not)
- ▶ For Grads, Incompletes must be made up in one year or a petition to the grad school is required.

Y (Why, oh why, do we have a Y?)

- ▶ History
- ▶ Today: no basis for grade (student never showed up, never turned in homework, never took a quiz or exam; i.e., there is no basis on which to calculate a grade)
- ▶ Y does NOT mean "yes!"

Other marks: AU, W and X

- ▶ AU: Student is enrolled for audit
- ▶ W: Student withdrew after day 6 of the term
- ▶ X: Grade has not been submitted and the grading deadline has passed

Grade Changes

- ▶ Faculty on contract can change grades as late as 1 year after the term the original grade was posted so long as the student has not graduated.
- ▶ Legitimate changes:
 - ▶ Instructor Correction (grading error)
 - ▶ To submit a missing/late grade
 - ▶ To record a Student Conduct Sanction grade
 - ▶ To record the final grade for an incomplete

Grade Changes

- ▶ Not Legitimate changes:
 - ▶ As part of a student negotiation, pressure
 - ▶ After allowing one student to re-do work in order to raise the final grade (did the other 35 students in the class get this opportunity?)
 - ▶ As a reward for enrolling in a second class with you
 - ▶ To help a student airbrush their transcript, save them from academic disqualification, etc. (no changing grades to Incompletes or grades to Y)

Grade Changes

- ▶ Department Head Involvement
 - ▶ Countersign SGRs for faculty no longer on contract
 - ▶ Countersign SGRs for all grades more than one year old
 - ▶ Sign SGR if the faculty member is unavailable to enter a grade in DuckWeb

Records are sealed...

- ▶ University of Oregon academic records are sealed thirty days after the conferral of a degree. After this date, changes to majors and minors, addition of departmental honors, removal of incompletes, grade changes, or other changes to an academic record cannot be made.

Contested Grades: three steps

- ▶ Student tries to work out the issue with the faculty member.
- ▶ Student appeals to the head of the department. (you can change the grade but you don't have to).
- ▶ Student submits a Scholastic Review Committee Petition.

Definitions

- ▶ School Official
- ▶ Education record
- ▶ Education need to know
- ▶ Directory information

Directory Information List

- ▶ your full name
- ▶ mailing and permanent address(es) and telephone number(s)
- ▶ e-mail address
- ▶ the fact that you are or ever were enrolled
- ▶ enrollment status (e.g., full-time, half-time or less than half-time)
- ▶ class level and majors/minors
- ▶ dates of attendance
- ▶ degrees, honors or awards received
- ▶ cumulative credit hours
- ▶ participation in officially recognized activities
- ▶ your status as a graduate teaching fellow and your teaching assignment, if applicable

Consent Forms

- ▶ Four pieces to be valid:
 - ▶ What (information is to be released)
 - ▶ To whom
 - ▶ For what purpose
 - ▶ Signature and date (no emails!)
- ▶ **Even with consent, we are not required to disclose.**
- ▶ We have very few blanket releases here at UO
 - ▶ Oregon Child Support
 - ▶ Letters of Reference

Parents

- ▶ Talk in generalities:
 - ▶ 90% is the cutoff for an A in my class.
 - ▶ Attendance policy is half a letter grade for each day missed.
- ▶ Tell parents to have their students set up a proxy account in DuckWeb.
- ▶ You can always:
 - ▶ Say that FERPA prevents you from sharing student information.
 - ▶ Refer parents to the University Registrar.
